#### **WORLD - SAF could compensate for loss of biofuel demand**

The global demand for ethanol from the land transportation sector should peak around 136 billion L in 2030, and will slowly drop towards 2050, according to S&P Global Commodity Insights. However, the agency noted that ethanol demand for sustainable aviation fuel (SAF) could surge to 42 billion L by 2050. And FGV Energia estimated that Brazil could make 6-9 billion L of SAF from waste feedstocks alone, enough to meet the country's entire demand for aviation fuel. (Novacana & Terra)

# **INDIA - ISMA signs deal to develop SAF production**

ISMA signed a memorandum of understanding with The Energy and Resources Institute (TERI) and PRAJ Industries to develop the production of sustainable aviation fuels (SAF), along with other bioenergy solutions. (Chini Mandi & Informist)

#### **COSTA RICA - Publishes details for ethanol mandate**

The Ministry of Economy, Industry and Commerce (MEIC) published technical details regarding an ethanol mandate, which is currently undergoing international public consultation. The plan would aim for an 8% mandate in 2023-26, and highlights that the Sugar Cane Industrial League (Laica) has the capacity to make 630,000L/year of ethanol. (El Observador)

#### **DOMINICAN REPUBLIC - Exports jump in 2014-23**

Sugar exports from the Dominican Republic grew by 1.16% annually between 2014 and 2023, and went from USD 96.925 million to USD 108.814 million, official data showed. The number of jobs in the sector, however, dropped by 22.9% on year in 2023. (El Dinero)

## FRANCE: Agreste estimates rise in sugarbeet production this year

France's sugarbeet production should total 34.38 million metric tonnes in 2024, up 8.4% from 2023 and 6.3% higher than the five-year average, according to French agriculture ministry agency Agreste.

Sugarbeet yield is estimated at 83.6 t/ha, the same as in 2023. The sugarbeet crop area in 2024 is estimated at 411,000 hectares, up from 379,000 hectares in 2023.

Agreste said in a report <u>released Sept. 17</u> that sugarbeets benefited from good weather conditions in August.

#### BRAZIL: Tereos' director says ethanol is key for global decarbonisation

Tereos' director of sustainability in Brazil, Felipe Mendes, has said that ethanol will be key for the global decarbonisation process, according to Agência Estado.

During an event on Sept. 16, in São Paulo, he said the industry needs to promote ethanol attributes to consumers and international players.

Mendes added that Brazilian ethanol has a competitive advantage over ethanol produced in the United States and Europe in terms of carbon emissions and cited sustainable aviation fuel (SAF) as an important alternative to increase global demand for ethanol.
