#### **THAILAND: Sugar production fell 20.4% in 2023/24**

The head of Thailand's Office of Sugar and Cane Board, Virit Viseshsinth, said on Sept. 23 that sugar production in country reached 8.8 million metric tonnes in 2023/24, down 20.37% from the previous season, according to Reuters.

He said sugar production is expected to increase 18% next year to 10.39 million tonnes.

#### UKRAINE: Sugar exports total 691,800 T in 2023/24

Ukraine exported around 691,800 metric tones of sugar in the 2023/24 season (Sept-Aug), according to a statement released by the Ukraine's sugar industry association Ukrsugar on Sept. 20, reports Sugaronline.

Around 77% of the total volume exported was shipped to countries in the European Union and 23% to other global markets.

Italy imported 19% of the total volume of sugar exported by Ukraine to the EU in 2023/24, followed by Bulgaria (18%) and Hungary (14%).

Cameroon accounted for 17% of the total Ukrainian sugar exported to countries outside the EU, followed by Libya (15%), Turkey (11%), Lebanon (9%), North Macedonia (8%), Israel (7%), and Burkina Faso (5%).

#### **UK: Beet growers start 2024/25 harvest**

Sugarbeet growers started harvesting for the 2024/25 campaign last week, completing deliveries into the Bury and Wissington sugar factories, according to Farmers Guide.

Farmer Alex Wilcox in Norfolk said that this year's crop has a better sugar content of 16.13%. He cited price drops as the biggest challenge for sugarbeet growers currently.

British Sugar's Bury St Edmunds and Wissington factories officially opened on Sept. 16.

## BRAZIL: Raízen more concerned about impacts of drought in 2025/26 than this season

Raízen's chief executive officer (CEO), Ricardo Mussa, said on Sept. 23 that he is more concerned about the potential impacts of the current drought on the 2025/26 sugarcane season than on the current season's crop, according to Reuters.

He said the fires affected the company's sugarcane fields, but the impact on the current 2024/25 season was not that significant at first.

Mussa added that if there is not enough rain in the coming months, a period usually of greater humidity, productivity could fall in the areas affected by fires already in development for 2025/26.

#### BRAZIL: Sugarcane sector contributes to 40% of São Paulo's agri-export revenue

Exports from São Paulo's sugarcane industry in the first eight months of 2024 accounted for 40% of the state's agricultural export revenue in the period, according to data released by the state government earlier this month, reports Sugaronline.

The sugarcane industry is the top contributor to the state's total agribusiness exports. The sector exported US\$7.91 billion worth of products in the first eight months of 2024, of which 93.1% was due to sugar shipments and 6.9% to fuel ethanol.

São Paulo's total agricultural exports reached US\$19.8 billion in the first eight months of 2024, up 9.3% year-over-year.

"We see agribusiness, once again, as the main responsible for controlling the trade deficit, driven once again by the sugar and alcohol, meat, forestry products and soybean complex sectors," São Paulo's secretary of Agriculture and Supply, Guilherme Piai, said in a statement.

# **EUROPE: EU crop monitor raises beet yield forecast amid favourable weather conditions**

The European Union's crop monitoring service increased the 2024 average yield forecast for sugarbeet in the region to 74.7 tonnes/hectare (t/ha), from <u>73.4 t/ha</u> estimated previously, due to favourable weather conditions in western parts of Europe, according to the latest <u>JRC MARS bulletin</u> released on Sept. 23, reports Sugaronline.

This latest estimate is also above the five-year average of 73.1 t/ha.

In France, the average sugarbeet yield forecast was increased to 83.5 t/ha, 4% above the previous estimate and 6% higher than the five-year average of 78.8 t/ha.

In Germany, sugarbeet benefited from the warm weather, abundant radiation and drying soils.

The yield estimate for the country's sugarbeet crop was raised to 77.1 t/ha, above the previous forecast of 74.5 t/ha and the five-year average of 75.9 t/ha.

In Spain, the sugarbeet yield estimate was increased by 1% from the previous forecast to 86.8 t/ha, up 7% from 2023 and 2% above the five-year average. "The sugarbeet harvest is almost complete in Andalucía, with regional authorities reporting positive yield estimates," the EU crop monitor said in the report.

Brazil Sugar Losses Make Thai and Indian Supply More Important - Bloomberg - Brazil's wildfires and drought that rattled the global sugar market have put the onus on Thailand and India to cover lost supplies. But both have offered recent reminders that they too face their own risks. Futures spiked to the highest since February this week as fears mount over crop damage from blazes, heat and dryness in top grower and exporter Brazil. That's threatening to raise costs for grocery goods from soft drinks to candy and shifting traders' focus to how output fares in fellow major producers. The good news is that the crop in No. 2 shipper Thailand is expected to rebound in the upcoming 2024-25 season. Yet September floods have provided a fresh warning of weather risks, with worries starting to surface that harvesting may be delayed if heavy rains continue. And in second-largest grower India, support for ethanol production means officials will likely prolong sugar-export curbs.
